### 4. First aid Measures

#### Description of necessary first aid measures

**Eye Contact:** Immediately hold eyelids apart and flush the eye continuously with running water. Ensure complete irrigation of the eye by keeping eyelids apart and away from eye and moving the eyelids by occasionally lifting the upper and lower lids. Continue flushing until advised to stop by the Poisons Information Centre or a doctor, or for at least 15 minutes. Transport to hospital or doctor without delay. Removal of contact lenses after an eye injury should only be undertaken by skilled personnel.

**Skin Contact:** Immediately remove all contaminated clothing, including footwear. Flush skin and hair with running water. (and soap if available). Seek medical attention in event of irritation.

- Inhalation:** If fumes or combustion products are inhaled remove from contaminated area.  
Lay patient down. Keep warm and rested.  
Prostheses such as false teeth, which may block airway, should be removed, where possible, prior to initiating first aid procedures.  
Apply artificial respiration if not breathing, preferably with a demand valve resuscitator, bag valve mask device or pocket mask as trained. Perform CPR if necessary.  
Transport to hospital or doctor.
- Ingestion:** For advice, contact Poisons Information Centre or a doctor at once.  
Urgent hospital treatment is likely to be needed.  
If swallowed do NOT induce vomiting.  
If vomiting occurs, lean patient forward or place on left side (head down position if possible) to maintain open airway and prevent aspiration.  
Observe the patient carefully.  
Never give liquid to a person showing signs of being sleepy or with reduced awareness; i.e. becoming unconscious.  
Give water to rinse mouth, then provide liquid slowly and as much as casualty can comfortably drink  
Transport to hospital or doctor without delay.

## 5. Fire Fighting Measures

Clear area of personnel and move upwind.  
Alert Fire Brigade and tell them location and nature of hazard.  
Wear full body protective clothing with breathing apparatus.

### Precautions for safe handling:

- Safe Handling:** Avoid all personal contact, including inhalation.  
Wear protective clothing when risk of exposure occurs.  
Do NOT allow clothing wet with material to stay in contact with skin.

Keep containers securely sealed.  
Store in a cool, dry, well-ventilated area.  
Store away from incompatible materials and foodstuff containers.  
Avoid contact with strong acids, acid chlorides, and acid anhydrides.
